## UDENRIGSMINISTERIET

Udvalget udbeder sig ministerens besvarelse af følgende spørgsmål:

### Spørgsmål 51:

Vil ministeren redegøre for, i hvilket omfang regeringens ministerier i lighed med Erhvervs- og vækstministeriet (som beskrevet i bl.a. Version2's artikel af 16. januar 2012: "EU-formandskab betaler 289.000 for 40 iPads til gallamiddag og 'uformelt ministerrådsmøde'") lejer iPads, software og lignende udstyr til brug ved møder, der afholdes som et led i Danmarks varetagelse af EU-formandskabet. Redegørelsen bedes indeholde en oversigt over antal møder, mængden af udstyr per møde samt udgifterne forbundet ved leje af udstyr til de enkelte møder

### Svar:

Udgifterne forbundet med EU-formandskabet til aktiviteter i Danmark dækkes dels af en tværministeriel ramme på i alt 260 mio. kr. og dels af de involverede ministerier. Den tværministerielle ramme er forudsat at dække udgifterne forbundet med bl.a. opbygning og indretning af conferencefaciliteter, herunder standard IT-infrastruktur.

Møderne arrangeres efter et back-to-back princip, hvor conferencecentre indrettes og opbygges, således at der kan afholdes møder i forlængelse af hinanden ved benyttelse af den samme infrastruktur. Det betyder, at der ikke opereres med særskilte budgetrammer for de enkelte møder i forhold til rammen på 260 mio. kr.

De enkelte ministerier får adgang til en standard mødepakke, der udover bl.a. lokaler inkluderer det nødvendige IT-udstyr for at kunne gennemføre møderne på en ansvarlig og effektiv måde. I standardpakken indgår ikke særligt udstyr som iPads eller lignende, men standard IT-infrastruktur såsom trådløst internetadgang, internethastighed, sikring af mobilnetværk, etablering af ca. 30 PC arbejdsstationer med printere samt ekstra netværksudtag til medbragte bærbare pc'ere, etablering af mediearbejdspladser med bærbare pc'ere, printere og netværksudtag, etablering af mediebase til elektronisk presse (internet, telefon, tv-skærme mv.) samt etablering af pc-arbejdsstationer i arbejdslokaler og i registreringsområde. Hertil kommer AV-udstyr i form af bl.a. skærme, bordmikrofoner, og tolkeudstyr.

Beslutninger om og udgifter til indkøb af eventuelle ydelser udover standard mødepakken påhviler det enkelte ministerium.

Der vedlægges en kalenderoversigt over de forudsete centralt planlagte uformelle ministtermøder og embedsmandsmøder i Danmark under EU-formandskabet.
