Til underretning for Folketingets Europaudvalg vedlægges Udenrigsministeriets besvarelse af spørgsmål 1 ad 2799+2800 - rådsmøde (almindelige anliggender og eksterne forbindelser) den 14.-15. maj 2007 vedrørende bilaterale aftaler uden for Doha-rundens regi.

**Spørgsmål 1 - Ad 2799+2800 Rådsmøde (almindelige anliggender og eksterne forbindelser) den 14.-15. maj 2007 til udenrigsministeren vedr. statusredegørelse for, hvilke lande der har indgået bilaterale aftaler uden for Doha-rundens regi, jf. punkt 2 på rådsmødedagsordenen.**

”Ministeren bedes - som lovet på Europaudvalgets møde 11/5 2007 - sende udvalget en statusredegørelse for, hvilke lande der har indgået bilaterale aftaler uden for Doha-rundens regi, jf. punkt 2 på rådsmødedagsordenen.”

Svar:

Det bemærkes, at bilaterale handelsaftaler – eller regionale handelsaftaler (som er den betegnelse, der oftest anvendes i WTO) – siden starten af 1990'erne blevet langt mere udbredt.

Som det fremgår af vedlagte lister, havde WTO pr. 1. marts 2007 modtaget notifikation om i alt 194 regionale handelsaftaler, der var trådt i kraft. Til sammenligning var der ved WTO's etablering i 1995 kun ca. 50. Bilag 1 lister de notificerede aftaler blandt andet med angivelse af aftaleparter, dato for ikrafttræden og notificering, hjemmelsgrundlag og aftaletype. Bilag 2 giver et overblik over udviklingen i antallet af regionale handelsaftaler frem til 2007.

Der er tale om en global tendens, idet så godt som alle WTO medlemmer har notificeret indgåelse af – eller efterfølgende tilslutning til - én eller flere regionale aftaler.

WTO anslår, at ca. 90% af de regionale handelsaftaler er frihandelsaftaler, mens ca. 10% er toldunioner.
